# ARTICLES OF ORGANIZATION OF BISCAYNE TITLE AND TRUST, LLC

The undersigned members to these Articles of Organization hereby associate themselves together to form a Limited Liability Company under the laws of the State of Florida.

# ARTICLE

#### NAME

The name of this Limited Liability Company is BISCAYNE TITLE AND TRUST, LLC

#### ARTICLE II

#### GENERAL NATURE OF BUSINESS
