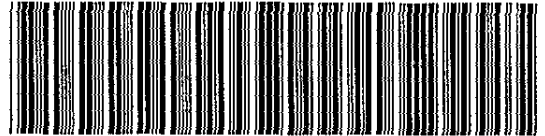

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:



ARTICLE VI - Members Rights to Continue Business:


