

ARTICLES OF ORGANIZATION

OF

R AND S CAR RENTAL, LC

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be R AND S CAR RENTAL, LC.

2. The duration of the Limited Liability Company shall be perpetual.

3. The mailing address and street address of the principal office of the Limited Liability Company is 1030 West Jefferson Street, Brooksville, Florida 34601.
