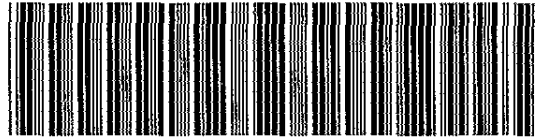


ARTICLE IV - MANAGEMENT

Pursuant to section 608.4235 of the Florida Limited Company Act, no members of the Company shall be an agent of the Company solely by virtue of being a member.


