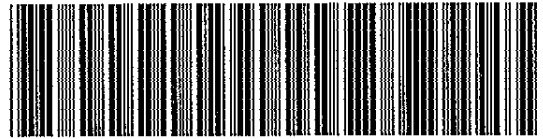



**Article I. Name:** The name of the Limited Liability Company is **PRISM REALTY, LLC**.


