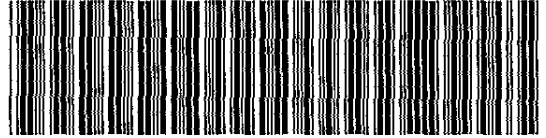

1. Name. The name of this limited liability company is **NANCY SCHNEID, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, subject to the Operating Agreement of the Company.

4. Place of Principal Office. The mailing address and the street address of the Company's principal office is **2413 Bayshore Boulevard, #1406, Tampa, Florida 33629.**

5. Registered Agent and Office. The name of the initial registered agent of the Company is **Nancy Schneid**. The street address of the initial registered agent of the Company is **2413 Bayshore Boulevard, #1406, Tampa, Florida 33629.**

6. Management of the Company. The Company is to be managed by one or more managers and is, therefore, a manager-managed company. The initial manager of the Company is **Nancy Schneid**.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

8. Additional Members. Additional members to the Company may be admitted only as permitted under the Company's Operating Agreement.

The undersigned executed these Articles of Organization effective on the 26th day of January, 2006.


