THE UNDERSIGNED, in order to form a limited liability company, pursuant to the Florida Limited Liability Company Act, Fla. Stat. Ch. 608.401 et. seq. (1993) respectfully states as follows:

1. Name. The name of the limited liability company shall be "MMI ADVERTISING, LLC".
2. Duration. The duration of the limited liability company shall be no longer than May 1, 2048.
3. Purpose. The purpose of the limited liability company shall be to engage in the business of advertising, including internet advertising, but this statement of purpose shall not restrict the limited liability company from engaging in any lawful business which the Members of the limited liability company deem appropriate.

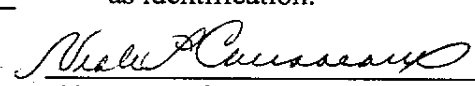

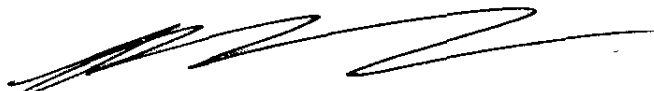
