**Members Right to Continue Business**

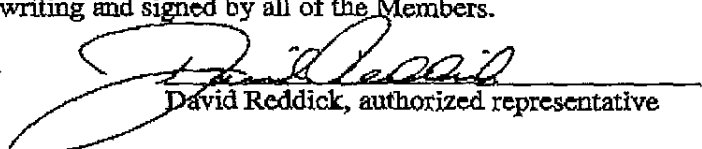

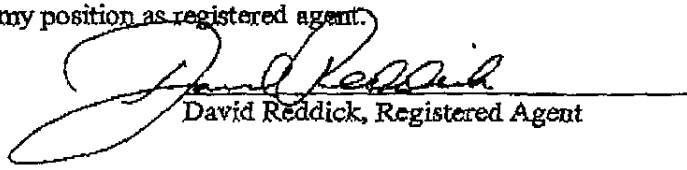
**ARTICLE TWELVE**
