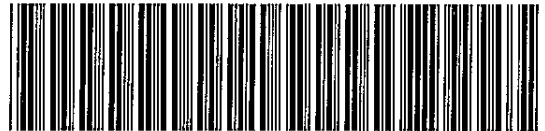

ARTICLE X – MANAGEMENT

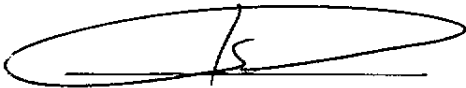

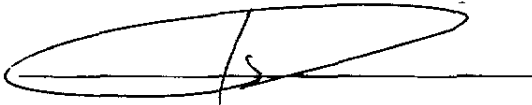
