ARTICLES OF ORGANIZATION
OF
JDL Berkeley Holdings, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be JDL Berkeley Holdings, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 4000 N. Federal Highway, Suite 201, Boca Raton, Florida 33431.

ARTICLE III - DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company's existence shall be perpetual.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the state of Florida is Jeffrey A. Levine, 4000 N. Federal Highway, Suite 201, Boca Raton, Florida 33431.

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the Company shall contribute to the capital of the Company in the form of cash only. The Operating Agreement of the Company shall provide additional restrictions concerning such contributions.

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make such additional capital contributions to the Company as required from time to time, as established by the Operating Agreement of the Company.

ARTICLE VII - ADMISSION OF NEW MEMBERS

Additional members shall be admitted to the Company in accordance with the Operating Agreement of the Company and on such terms and conditions as shall be determined by the Operating Agreement. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the managers of the company approve same.

ARTICLE VIII - TERMINATION OF EXISTENCE

The remaining members of the Company shall continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or on the occurrence of any other event which would terminate the membership of a member in the Company.

ARTICLE IX - MANAGEMENT

The Company shall be managed by a manager in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. The name and address of the initial manager(s) of the Company are Jeffrey A. Levine of 4000 N. Federal Highway, Suite 201, Boca Raton, Florida 33431 and Debra K. Levine of 4000 N. Federal Highway, Suite 201, Boca Raton, Florida 33431. Either Manager may act alone on behalf of the Company.

ARTICLE X - VOTING

All members of the Company shall be entitled to vote on matters relating to the Company. Each member shall have one (1) vote for each share of the Company which they own.


