# ARTICLES OF ORGANIZATION

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

#### 1. Name.

The name of the limited liability company is JKD, LTD. CO. (hereinafter refinited to the "Company").

#### 2. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the perduration of the Company shall be perpetual.

## 3. Purpose.

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

#### 7. Members.

## 8. Continuity of Business.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

# 9. Management.

The overall management and control of the business and affairs of the Company shall be vested in a manager, Gurcharn S. Dang shall serve as the initial Manager.

#### 10. Indemnification.

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
