



ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF RED BIRD RESEARCH & DEVELOPMENT, LLC



The Articles of Organization of Red Bird Research & Development, LLC, a Florida limited liability company (the "Limited Liability Company"), are hereby amended as follows:

1. The terms of Article I of the Articles of Organization are hereby deleted in their entirety and the following is substituted in lieu thereof:

"ARTICLE I
