ARTICLES OF ORGANIZATION
OF
DATA RESOURCE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Fla. Stat. ch. §§ 608.401 et seq., as amended from time to time (or any corresponding provisions of succeeding law) (the "Act"), hereby make, acknowledge, and file the following Articles of Organization. Capitalized terms used in the Act and also used herein are intended to have the same meaning herein as defined in the Act.

ARTICLE I - NAME

The name of the limited liability company shall be, DATA RESOURCE, LLC ("Company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The Company commenced its existence on February 2, 2006. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or the Operating Agreement.

ARTICLE VI - ADMISSION OF NEW MEMBERS

The initial Member may admit additional Members upon such terms and conditions as the initial Member may determine appropriate.

ARTICLE VII - OPERATING AGREEMENT; ADMISSION OF NEW MEMBERS

After an Operating Agreement is adopted, a Majority in Interest of the Members shall have the right to admit additional Members upon such terms and conditions as are provided in the Operating Agreement governing the Company. Transfers of a Member's interest in the Company may be made only upon compliance with the terms and conditions set forth in the Operating Agreement governing the Company. Membership Interests may be either voting or non-voting, as provided in the Operating Agreement.

ARTICLE VIII - MANAGEMENT; MANAGER-MANAGED COMPANY

The Company shall be managed by one or more Managers. The name and address of the initial Manager is:

ARTICLE IX - CAPITAL CONTRIBUTIONS

The initial Member and subsequent Members will make the contributions required by the Operating Agreement, if any. No Member shall have any personal liability for any obligation of the Company.

ARTICLE X - TERMINATION OF EXISTENCE

The Company shall be dissolved and its affairs wound up and terminated upon the determination by a Majority in Interest of the Members to dissolve the Company.


ARTICLE XI- AMENDMENT




