ARTICLE I - Name

The name of the limited liability company is CJH, LLC.

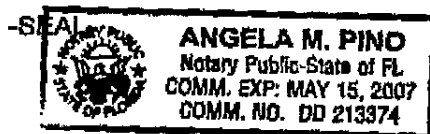


