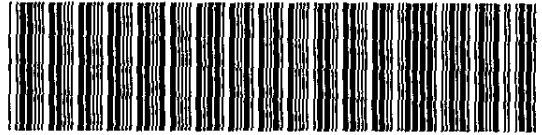



The name and street address of the initial Registered Agent of the Company is A. M. Hochstadt, at 289 Key Palm Road, Boca Raton, Florida 33432.


ARTICLE IV
