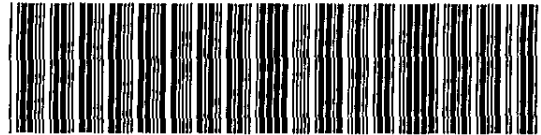

**ARTICLE 1 – Name.** The name the limited liability company shall be Share A Dream Properties, LLC.

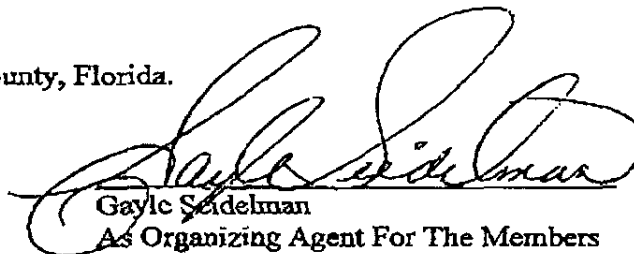
