



ARTICLES OF ORGANIZATION OF Insignia, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Company Act (Chapter 608 of the Florida Statutes), hereby make, acknowledge, and file the following Articles of Organization

ARTICLE I - NAME
