ARTICLES OF ORGANIZATION
FORLAW OFFICES OF JODY H. OLIVER, LLC
a Professional Florida Limited Liability CompanySECRETARY OF STATE

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 608, Florida Statutes, entitled the Florida Limited Liability Company Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be LAW OFFICES OF JODY H. OLIVER, PLLC
2. PURPOSES. The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:
- To engage in the practice of law, and to take all actions that are necessary or proper in connection with that practice.
 - To engage and render the professional services involved only through its officers, agents and employees who shall be duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation. Employees, as used herein, shall not include clerks, secretaries, bookkeepers, technicians or other assistants who are not usually and ordinarily considered by custom and practice to be rendering professional services to the public for which a license or other legal authorization is required.
 - To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law and to own real or personal property necessary for the rendering of professional services.
 - To engage in no other business other than the rendition of the professional services specified herein.
 - To do everything necessary and proper in accomplishing the purposes herein set forth and to do any thing incidental thereto which is not forbidden under the laws of the State of Florida.
3. Duration/Continuation. The period of this company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the company subsequent to the foregoing events.
4. The mailing address and the street address of the company is 800 Village Square Crossing, Suite 205, Palm Beach Gardens, Florida 33410.
5. Registered Agent and Office. The name and street address of the initial registered agent and office for this company is as follows: Jody H. Oliver, Esquire, 800 Village Square Crossing, Suite 205, Palm Beach Gardens, Florida 33410.
6. Admission of Additional Members; and Terms and Conditions of such Admission: Additional members may be admitted only upon the approval of the majority of the nontransferring

members of the Company upon the written application of such new member, in the manner set forth in the Operating Agreement of the Company.

7. **Right to Continue Business.** Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members.

8. **Management of Company.** The management of the Company is reserved to one or more managers. The names and addresses of the Managers, who shall serve until the first annual meeting of members or until their successor is elected and qualified, is:

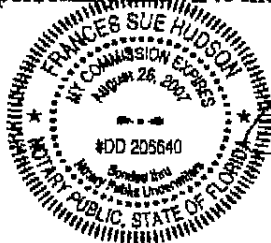

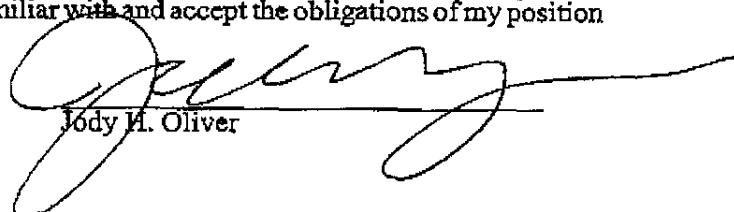

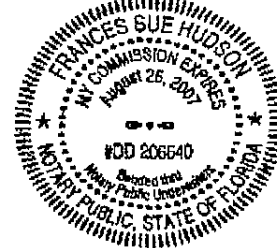
