ARTICLES OF ORGANIZATION**OF****BULLSEYE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act F.S. Chapter 608, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company shall be BULLSEYE, LLC (hereinafter referred to as the "Company").

ARTICLE II - Address:

The mailing address of the principal office of the Company is Post Office Box 99, Gulf Breeze, Florida, 32561 and street address of the principal office of the Company is 77 Baybridge Office Park, Gulf Breeze, Florida, 32561.

ARTICLE III - Duration:

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization and/or the Company's operating agreement.

ARTICLE IV - Management:

The Company is to be a manager-managed company and is to be managed initially by Alan N. Overbaugh and Mark Lyons III.

ARTICLE V - Admission of Additional Members:

No additional members shall be admitted to the Company except as set forth in the operating agreement of the Company. Any member may transfer his or her interest in the Company as set forth in the operating agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the transfer complies with the requirements set forth in the operating agreement.


