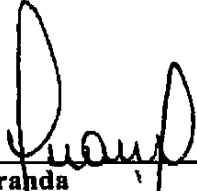
**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
JBC HOLDINGS, LLC,
a Florida limited liability company**

Pursuant to Section 608.411, Florida Statutes, Article IV is hereby added to the Articles of Organization of **JBC HOLDINGS, LLC**, a Florida limited liability company filed on February 6, 2006, under Document # L06000013308, hereinafter referred to as the "Company", to read as follows:

ARTICLE IV - Management of the Company

The Member hereby appoint Joao Batista Feliciano da Costa of 5373 Fisher Island Dr., Unit 5373J, Miami, FL 33109, as the initial Manager of the Company who shall serve as such until his resignation or earlier removal under the Operating Agreement of the Company. The Manager is hereby granted the right, power, and authority to do on behalf of the Company all things which are necessary or appropriate to manage the Company's affairs and fulfill the purposes of the Company, including delegating his management powers to officers, employees, agents or other representatives of the Company. Any and all persons dealing with the Company shall have the right to rely upon the actions of the Manager to bind the Company by his actions or signature without the need to obtain any written consent or permission from the Members to so bind the Company.
