**ARTICLES OF ORGANIZATION
FOR

ARTICLE I. Name.

The name of the Limited Liability Company is Grass River Publishing, LLC.

ARTICLE II. Address.

The mailing address and street address of the principal office of the Limited Liability Company is 5510 SW 7th Street, Margate, Florida 33068.

ARTICLE III. Duration.

The period of duration for the Limited Liability Company shall be perpetual.

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed

ARTICLE VII. Members Rights to Continue Business.

The remaining members of the Limited Liability Company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, provided that there are at least two remaining members.

ARTICLE VII. Affidavit of membership and Contributions.
