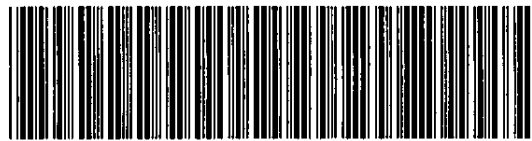


FIRST: The Articles of Organization were filed on February 6, 2006 and assigned document number L06000013357.
