**ARTICLES OF ORGANIZATION OF
KING FLOORING, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be FULLER CONSTRUCTION AND TRIM, LLC.

**ARTICLE II
ADDRESS**

The mailing address and street address of the principal office of the company shall be 141 Menzel Street, Valparaiso, Florida 32580.

**ARTICLE III
DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall not be perpetual and shall terminate upon the happening of one of the conditions provided in Article VII of these Articles of Organization.

**ARTICLE IV
REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the State of Florida is Stephen Fuller, 141 Menzel Street, Valparaiso, Florida 32580.

**ARTICLE V
ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the company except by the express consent of the managing member of the company and on such terms and conditions as shall be determined by the managing member.

**ARTICLE VI
TRANSFERABILITY OF INTERESTS**

A member may transfer or assign his or her interest in the company only upon the express consent of the managing member of the company.

**ARTICLE VII
TERMINATION OF EXISTENCE**

The company shall be dissolved upon the bankruptcy, death, dissolution, expulsion, insanity, resignation, retirement or withdrawal of a member or upon the occurrence of any other event that terminates the continued membership of a member in the company, unless the managing member expressly consents to the continuation of the company.

**ARTICLE VIII
TRANSFERABILITY OF INTERESTS UPON DEATH OF MEMBER**

Upon the death of a member, the deceased member's interest in the company shall be divided in such a manner as the managing member deems fit.

**ARTICLE IX
MANAGEMENT**

The company shall be managed by the managing member in accordance with operating agreement adopted by the managing member for the management of the business and affairs of the company. This operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.
