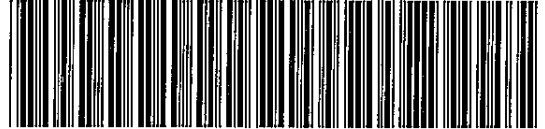

ARTICLE I

NAME

The name of this limited liability company is T M CAPITAL, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

PRINCIPAL OFFICE, MAILING ADDRESS AND
REGISTERED AGENT

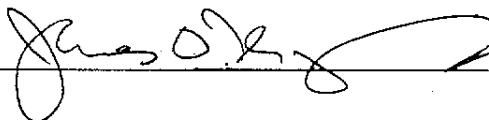

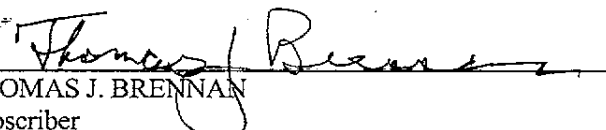
