ARTICLES OF ORGANIZATION

WEER THE STATE OF The undersigned, for the purpose of forming a limited liability company und the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be D&R AUTO BODY AND DETAILING LLC, ("Company").
