**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
ASAP INSTALLATIONS LLC**

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, ASAP INSTALLATIONS LLC, a Florida limited liability company (the "Company"), whose articles of organization were filed with the Secretary of State of Florida on February 7, 2006, does hereby certify that these Amended and Restated Articles of Organization were duly adopted by the sole Member of the Company by a Written Consent of the Member on June 1, 2011.

The text of the Articles of Organization of the Company is hereby amended and restated in its entirety, effective as of the date of filing of these Amended and Restated Articles of Organization with the Secretary of State of Florida, as follows:

**ARTICLE I

The Company is to be managed by its Manager or Managers, as set forth in its Operating Agreement, and is therefore a manager-managed company.


