# ARTICLES OF ORGANIZATION OF DELTURA CAT SCAN SERVICES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

#### ARTICLE 1. NAME
