ARTICLES OF ORGANIZATION OF CREATIVE RECYCLING TECHNOLOGIES, LLC

The undersigned hereby executes these Articles of Organization ("Articles") for purpose of forming a limited liability company in accordance with the laws of the State Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

Registered Office and Registered Agent
