**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**

**ARTICLE II.

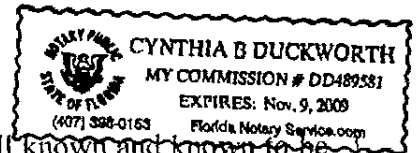
**ARTICLE V.


