Principal Office

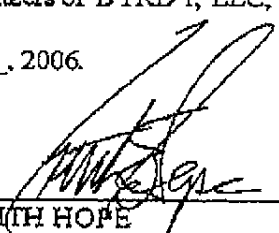
The street address of the principal office of the Company shall be 5614 Guava Street, Holmes Beach, Florida 34217, and the mailing address shall be the same.

Registered Agent and Office

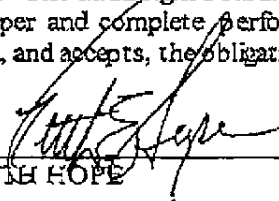
