**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
APPALACHIA LAKEVIEW, LLC**

The undersigned, acting as the Manager of Appalachia Lakeview, LLC hereby adopts the following Amended and Restated Articles of Organization pursuant to §605.0202 of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes ("Act"), for the purpose of amending and restating the Articles of Organization of the company filed with the Florida Department of State on May 14, 2008:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE




