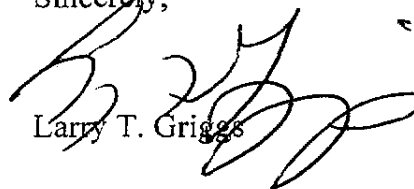

Name

The name of the limited liability company ("Company") is WMKG, LLC.

ARTICLE II

Indemnification

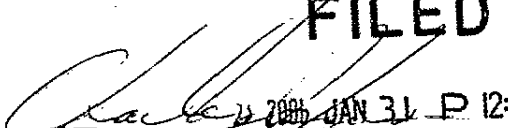

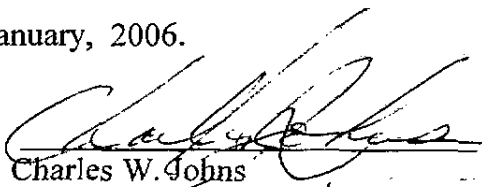
