ARTICLES OF ORGANIZATION OF TDM, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be TDM, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 600 N. Congress Avenue, Suite 160, Delray Beach, Florida 33445.

ARTICLE III -- DURATION
