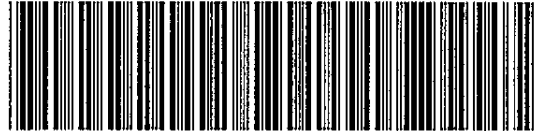

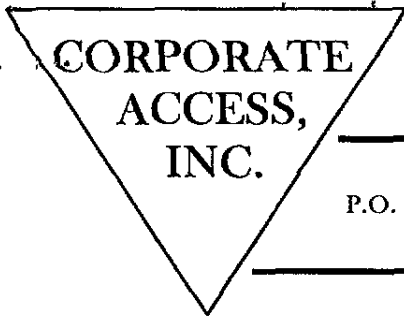

**ARTICLE I**  
**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company shall be URBAN FLATS (VERANDA), LLC and its principal office and mailing address shall be 601 North New York Avenue, Suite 201, Winter Park, Florida 32789, but it shall have the power and authority to establish branch offices at any other place or places as provided in the Operating Agreement, as it may be amended from time to time.

**ARTICLE II**  
**DURATION**

The period of duration of the limited liability company shall be perpetual except as it may be dissolved as set forth in the Operating Agreement (as it may be amended from time to time).

**ARTICLE III**
