

ARTICLES OF ORGANIZATION OF BRAZILIAN SECRET CAFÉ, LLC

ARTICLE I

Name

ARTICLE VII




CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
