ARTICLES OF ORGANIZATION
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), and Chapter 621 of the Florida Statutes (the "Professional Service Corporation and Limited Liability Company Act") for the purpose of forming a Professional Limited Liability Company (within the meaning of Section 621.03(3), Florida Statutes) under the laws of the State of Florida do set forth the following:

1. **NAME.**

The name of the Limited Liability Company is DAVID T. WOODHAM, D.V.M., PLLC (hereinafter referred to as the "Company").

2. **PERIOD OF DURATION.**

The period of duration of the Company shall be from the date on which these Articles of Organization are accepted for filing by the Department of State, State of Florida, which shall be the effective date of the Company's existence, until the first to occur of the following:

- (i) Dissolution of the Company pursuant to the provisions of the Florida Limited Liability Act; or
- (ii) By the mutual written agreement of a majority in capital interest of the Members; or
- (iii) As provided for in any written Operating Agreement signed by all of the Members.

3. **PURPOSE.**

The purpose for which the Company is organized is to engage in and carry on the practice of veterinary medicine in the State of Florida and in such other states as the Company and its Members may be qualified to practice veterinary medicine, and all activities incident thereto. The Company shall have all of the powers vested in a professional limited liability company organized and existing by virtue of Chapter 608, Florida Statutes, and Chapter 621, Florida Statutes.

4. **ADDRESS OF PLACE OF BUSINESS.**

The mailing address and the street address of the place of business for the Company is 2323 Centerville Road, Tallahassee, Florida 32308. Such address may be changed from time to time as provided in the Operating Agreement.

5. **REGISTERED AGENT.**

The initial registered agent in Florida for the Company is David T. Woodham, D.V.M., and the initial registered office is located at 2323 Centerville Road, Tallahassee, Florida 32308.

6. **CAPITAL CONTRIBUTIONS.**

The Members shall make such initial and additional contributions to the capital of the Company as may be required pursuant to the written Operating Agreement.

7. **MEMBERS.**

(a) The Company shall have at least one (1) Member. All persons designated as "Members" shall have all of the rights of members allowed under Chapter 608, Florida Statutes, and Chapter 621, Florida Statutes, and such rights, duties and obligations as may be contained in the Operating Agreement. The following person is the initial Member:

David T. Woodham, D.V.M.

(b) The Company may admit additional Members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement.

(c) A person may not be a Member unless such person is (i) an individual who is duly licensed to practice veterinary medicine in the State of Florida; or (ii) a professional corporation, association, limited liability company or partnership, all of the individual shareholders, members or partners of which are duly licensed to practice veterinary medicine in the State of Florida.

8. **CONTINUITY OF BUSINESS.**

If the company has more than one (1) Member, then upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

9. **MANAGEMENT.**

Management of the Company is reserved to its Members. The Members may, however, elect a Managing Member (hereinafter, a "Manager") in the manner provided in the Operating Agreement. Any such Manager shall have the powers and authority expressly granted under the Operating Agreement or by written resolution of the Members holding a majority of the outstanding ownership interest in the Company.

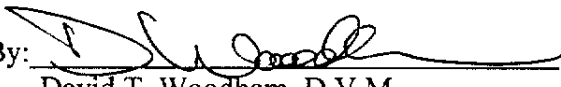
10. **INDEMNIFICATION**

Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member, Manager or former Member or Manager to the full extent permitted

under Florida law.
