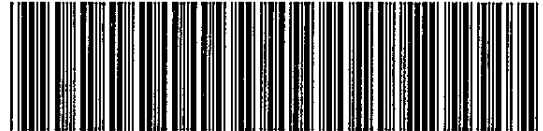

The Articles of Organization were filed on February 14, 2006 and assigned document number L06000016232.


SECOND
