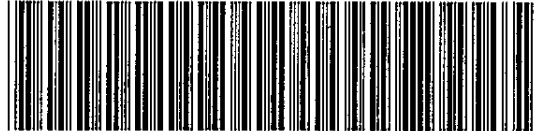

The name of the Limited Liability Company is MERRILL-STEVENS YACHT MANAGEMENT, LLC (the "Company").


ARTICLE II - Address
