ARTICLE II

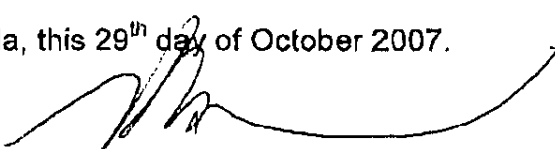
The principal address and mailing address for the Limited Liability Company is: 400 Alton Road, Suite 703, Miami Beach, Florida 33139.
