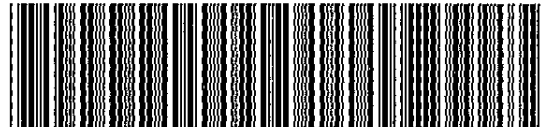



The undersigned member hereby forms a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME

ARTICLE VII. DISSOLUTION OF COMPANY

Upon the death of the founding member, Minerva A. Simpson, all aspects of her membership are to pass to any person or persons identified in an Operating Agreement. Upon the retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the Company shall be dissolved unless all of the remaining members consent to continue the Company.


ARTICLE IX. RETURN OF CAPITAL


