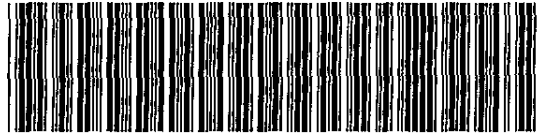

**ARTICLES OF ORGANIZATION
FOR

Pursuant to Chapter 608, Florida Statutes, the articles of organization are as follows:

ARTICLE I

NAME OF LIMITED LIABILITY COMPANY
