Articles of Organization

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Metro Plantation, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

- 9. <u>Certificated Interests</u>. The members' interests in the Company may be evidenced by certificates.
