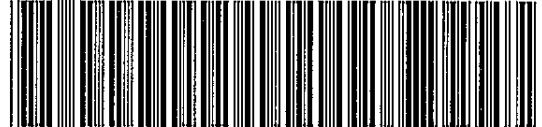

ARTICLE 1 - NAME

The name of the limited liability company shall be **J & M ENTERPRISES LLC**, ("Company").

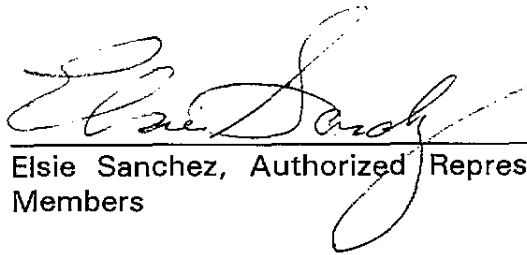

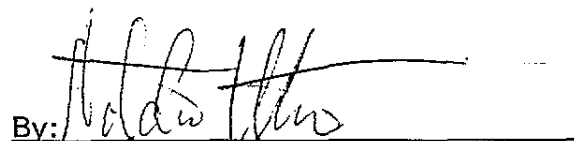
