# ARTICLES OF ORGANIZATION

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

### 1. Name.

The name of the limited liability company is 10960 HARMONY PARK DRIVE, LLC (hereinafter referred to as the "Company").

### 2. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

#### 3. Purpose.

The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

### 7. Members.

### 10. Indemnification.

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
