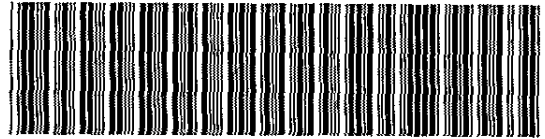

The company shall be a manager-managed company.


