

**ARTICLES OF ORGANIZATION  
OF**

**4 M of Jax, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be, **4 M of Jax, LLC**("Company"). The principal place of business of the Company and mailing address of the Company in Florida shall be **1466 Lakewood Drive, Jacksonville, FL 32259**

**ARTICLE II - DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

**ARTICLE III - PURPOSES AND POWERS**


## ARTICLE VII - MANAGEMENT

The Company shall be managed by one or more members and is, therefore, a member managed company.


