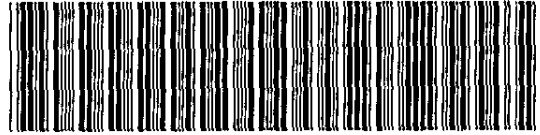


ARTICLE VI
