

ARTICLES OF ORGANIZATION OF SPECIFIED ENGINEERED LIGHTING, LLC

The undersigned, for the purpose of forming a multi member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME
