**ARTICLES OF ORGANIZATION
OF
SPECIFIED ENGINEERED LIGHTING, LLC**

The undersigned, for the purpose of forming a multi member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **SPECIFIED ENGINEERED LIGHTING, LLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be 4227 Gull Cove, New Smyrna Beach, Florida 32169 and the mailing address is the same.

ARTICLE III -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 
