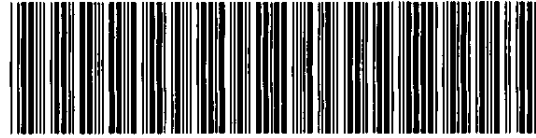

The undersigned, Paul R. Balliette, Managing Member, and Cindy J. Balliette, Secretary, of GATEWAY NORTH PROPERTIES, LLC hereby certify that:

1. They are the current Managing Member and Secretary of GATEWAY NORTH PROPERTIES, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on February 20, 2006.

2. The following Amendment to the Articles of Organization was unanimously adopted by the Members at a special meeting at which all of the Members were present and voting throughout, duly called for the purpose of adopting this Amendment and held on July 22, 2014.


